# Approval of Minutes of the December 9, 2021 Meeting

A motion was made and seconded to approve the December 9, 2021 meeting minutes. The motion carried unanimously.

#### **Public Comment**

Mr. Charles Love, spoke to the Authority Board on having a fabric covered dome hangar constructed at the airport. After a lengthy discussion with Board members and the airport consulting firm representative, it was determined a great deal of research would be needed on the product and consultation with the FAA on having that type of hangar on airport property.

The topic would be revisited by the Board at a later date.

# **Consultant's Report**

Jeff Tarkington of Talbert and Bright stated the FAA is working on the grading plan work for the Parallel Taxiway Extension, which involves the limits of disturbance. The review is running on schedule and should be moving to the next stage of work plan by Spring of 2023 at the latest.

He also mentioned that the Tappahannock Essex County Airport was possibly being approved by the FAA in February 2022 for a 5 year funding program that, if approved fully, would allow the airport to have funds distributed over a five year period to be used for major projects of infrastructure. The FAA and DOAV will confirm this information at the February 2022 Authority Board meeting, which is the annual joint meeting with both federal and state agencies.

Mr. Tarkington noted there are three future meetings of interest for State Aviation. February 3, 2022 is the Aviation Board meeting and also State Legislation Aviation Day at the General Assembly of Virginia.

The Spring Aviation Workshop will be held May 24 and 25, 2022 in Staunton, Virginia.

The Annual conference is scheduled for August, 2022 in Hot Springs, Virginia.

The airport will be represented at these meetings.

# <u>Airport Manager's Report & Recommendations</u>

Mr. Evans reported fuel sales were down in December, probably due to holidays and Covid non-travel.

He noted eight hangar renters took advantage of the annual lease payment offer. Also, he said the old, unused van was sold.

Mr. Evans said the Liability insurance is up for renewal this month, the paperwork had been processed, and the invoice would be submitted for payment shortly. Renewal is to be \$7,951.00 for 2022-2023.

## Treasurer's Report

Mrs. West discussed the budget report for December 2021.

The Virginia Resources Authority Semi-annual Bond payment has been paid and the payments from the Town of Tappahannock and Essex County had been received. There was no State grant reimbursal. There was an FAA grant reimbursal for \$50,038.52.

Payroll has increased as of January 1 for the part time employees due to minimum wage increase to \$11 an hour.

W-2s and filing of all Federal and State payroll forms will be completed by January 31, 2022.

The report was approved as presented.
