COUNTY ADMINISTRATOR'S and AGENCIES' REPORTS

Chairman's Report

Chairman Akers added this report to the regular meetings. He has also added three items to Board Docs: 1) rolling action items 2) meeting questions and comments and 3) Roberts rules of procedure. He has added a third Wednesday weekly meeting with the Town of Tappahannock to the calendar and he may schedule a regular meeting with the Schools. Chairman Akers requested the County Administrator begin soliciting RFP's for the construction of the joint maintenance facility. He said the EDA presented a grant opportunity to study water access and a second grant for public recreation mainly for the Poor House Farm tract. The grant deadline is April 14, 2022. Administrator Lombardo added that there is discretionary funding to pay for a grant writer. Chairman Akers said he will be developing a County dashboard.

County Administrator

Administrator Lombardo reported that the County has \$40k in ARPA funds earmarked to develop tourism. The Town of Tappahannock has funding for that also. He plans to develop a tourism website and hire a contractor to promote tourism. The Economic Summit will be held either March 17th or 24th in the evening. Particulars will be announced soon. The Zoning department has a new format for their report. Administrator Lombardo sent kudos to Chuck Huntley on the new Website draft.

Animal Shelter

Supervisor Magruder gave a shout out to the Animal Shelter team on their six year no euthanasia record. Administrator Lombardo mentioned that the Shelter received a generous donation of dog food and will give it away to anyone who needs help feeding their animals.
