Stated that a lot of hound dogs being rescued during hunting season. We need to be respectful of the animals.

Shared that the library now has a blood pressure machine. We are currently ranked highest for people dying of blood illness.

SCHOOL SUPERINTENDENT'S AND CONSTITUTIONAL OFFICERS' REPORTS

Commissioner of Revenue Tommy Blackwell stated that the Transient occupancy tax has been submitted to the board for review. The other is the 2022 Forest sustainability Fund. We did receive those funds but does require the board to determine how those funds will be spend with the guidelines that were set forth. It was not a lot of money \$7,622.23 for the first year.

Chairman Akers asked about the 6% and 3% could be rebated back to the owner of the property if they pay in a reasonable time. Are they billed 3% and if they don't pay they are billed the other 3% or do we bill them 6% and we rebate them 3%. Commissioner Blackwell stated that this is 3% of what we receive. It is also just a suggestion.

Commissioner Blackwell also stated that he drafted the ordinance but would like for the Board to send it to the Attorney.

Supervisor Magruder stated that the Forest Sustainability fund has to be used for education, outdoor recreation or forest conservation. We received \$7,622.23. During the budget time we should look at where to place this money and we should look at putting this money into next years budget and then we spend that and just base it on what we receive.

Chairman Akers asked if the board is ok to send the Transient Occupancy Tax ordinance to the attorney. They were all in agreement.

Commissioner Blackwell asked what they considered the timeline to be if they were going to have it follow with the Fiscal Year?

Supervisor Magruder suggested pushing it out with the Fiscal Year.

Vice Chairman Gill stated it still has to go for a public hearing as well so they will need that time.

Supervisor Johnson asked how many establishments do we think this will impact.

Commissioner Blackwell stated we have not received all of the business licenses but would guess around 3 dozen.
