Internship program with RCC – no update at this time

EDA Website Development – Mr. Smith and Mr. Holt provided an update and presented information regarding similar websites from Page and Fauquier counties. In discussions with Mr. Huntley, IT Director for Essex county, it was determined that hosting the website within the county website was likely the most cost effective and secure path forward.

Board of Supervisors/Town Council – Mr. Gill noted that the town and county have formed an Economic Development subcommittee with representation from the BOS – Mr. Gill and the town council – Mr. Troy Balderson. April and Eric will represent the county and town staff, respectively.
