#### JOB SUMMARY/PURPOSE

This position performs responsible work in responding to inquiries and complaints concerning animal control, enforcing animal control ordinances and related laws such as paid pet licenses, maintaining a safe and sanitary facility for animals and people in accordance with all applicable statutes, ordinances and regulations, and coordinating the animal adoption process. This position shall coordinate with the public when reclaiming, adopting process or admitting animals and is responsible for promoting responsible pet ownership in conversations with customers. The Animal Control Officer is responsible for all animal control enforcement as well as caring for and maintaining animals in the shelter; and is responsible for maintaining and improving upon the efficiency and effectiveness of all areas under his/her direction and control.

#### **ESSENTIAL JOB FUNCTIONS**

(The essential functions or duties listed below are intended only as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related or a logical assignment to the position.)

- Performs duties related to animal control including, but not limited to, responding to complaints, enforcing animal control ordinances (including requirements for tags), statutes, and laws, and ensuring public safety;
- Performs emergency animal rescue services, take animals to Veterinary as needed;
- Sedates dangerous or vicious animals in a safe and humane manner, as authorized; work with Sheriff's office if dangerous animal must be shot;
- Patrols assigned areas to engage in various animal control duties, including containing/retrieving sick, injured, stray, feral or unwanted animals and transporting them to the appropriate destination; take animals to Veterinarian;
- Communicates with the general public regarding proper animal care, wildlife problems and animal control regulations, explain to public about rabies shots needed to get dog tag;
- Prepares and maintains necessary reports and records;
- Performs duties related to the daily care of Shelter animals including cleaning and disinfecting of the animal holding areas and walkways;
- Performs continual maintenance and housekeeping duties including minor repairs and upkeep of the Shelter workrooms and public areas;
- Assists in performing health and behavior evaluations on individual animals:
- Monitors visitors to the Shelter to ensure the safety of citizens and animals;

- Assists customers who are seeking lost pets and those interested in adopting;
- Answers questions about the adoption process and/or specific animals, and assists customers in reclaiming their animals, or in completing adoption applications;
- Assists with the intake of animals ensuring accurate records are maintained;
- Performs various shelter related duties as required;
- Ensures that all work is conducted in a safe manner and all work safety practices are followed:
- Performs similar or related work as required, directed or as situation dictates;
- Assists other department staff as needed to promote a team effort to serve the public;
- Continues training; keeps current with animal control regulations, to maintain certification;
- Consistent on-site/field work and on-time attendance is essential for this position based on assigned schedule.

#### MINIMUM REQUIREMENTS TO PERFORM WORK

#### Education and Experience:

 High school diploma plus two-three year of experience with animals or any equivalent combination of education, training and experience that provides the requisite knowledge, skills, and abilities for this job, supplemented by six months of progressively responsible experience in animal control or a closely related field.

#### Licenses or Certificates:

- Animal Control Officer Certification within 12 months of hire.
- Valid Virginia Driver's License.

#### Knowledge, Skills and Abilities:

- Knowledge of the purpose and functions of animal control programs;
- Knowledge of best practices regarding control and containment of animals;
- Knowledge of the functions and responsibilities of the Tappahannock-Essex County Animal Shelter;
- Knowledge of the laws, ordinances, standards, and regulations pertaining to the specific duties and responsibilities of the Tappahannock-Essex County Animal Shelter;
- Knowledge of various breeds of dogs, cats and other domestic animals;
- Knowledge of normal and abnormal animal behavior, and symptoms of animal abuse;
- Knowledge of various equipment, materials and specialty items used in animal care and control procedures;
- Knowledge of occupational hazards and the ability to conform to safety precautions and procedures;
- Ability to handle and transport animals safely and securely;
- Ability to operate a vehicle safely and securely;
- Ability to read and interpret various materials pertaining to the responsibilities of Animal Control Regulations and Animal Care;
- Ability to maintain effective relationships with personnel of other departments, professionals, and members of the public through constant contact and cooperation;
- Ability to deal courteously, yet firmly and effectively with the public;

• Ability to use independent judgment and discretion in determining procedures, setting priorities, maintaining standards and resolving problems.
